

**Merchant Referral Program.** An existing merchant in Canada ("Merchant") who refers a prospective merchant in Canada ("Referred Merchant") to the DoorDash platform may be eligible to receive a referral bonus ("Referral Bonus") from DoorDash Technologies Canada Inc. ("DoorDash") (collectively, the "Merchant Referral Program"). Participation in the Merchant Referral Program is subject to the DoorDash Merchant Terms of Service. To submit a referral, Merchant must complete the form available at <https://get.doordash.com/en-ca/about/merchant-referral-program>. By submitting a referral, Merchant represents and warrants that Merchant has a personal relationship with the Referred Merchant and that Merchant has obtained full rights and authorization to share Referred Merchant's contact information with DoorDash for DoorDash's marketing and business purposes.

**Term.** The Merchant Referral Program ends on December 31, 2024, unless terminated earlier by DoorDash at DoorDash's sole discretion.

**Eligibility.** The referring Merchant must be a current DoorDash Marketplace Merchant located in Canada in good standing on the DoorDash platform. Merchant will receive a Referral Bonus of CA\$500, inclusive of any applicable Canadian Sales Taxes, for each of the first 10 Referred Merchants that Merchant refers. For Merchant to be eligible for the Referral Bonus, the Referred Merchant must sign up for the DoorDash platform and successfully fulfill at least 15 Marketplace customer orders within 60 days of activation on the DoorDash platform. A Referred Merchant must be (a) a restaurant and (b) a small business (75 stores or fewer). In the event a Referred Merchant is referred by multiple Merchants, only the first Merchant (as determined by DoorDash in its sole discretion) to refer to the Referred Merchant will be eligible to receive a Bonus Referral for any particular Referred Merchant. DoorDash reserves the right to increase the limit of Referred Merchants at DoorDash's sole discretion. Merchant and Referred Merchant must be located in Canada to be eligible. DoorDash reserves the right to deactivate or invalidate any Referral Bonuses obtained by Merchant in excess of these amounts.

**Taxes.** Merchant is responsible for remitting all Canadian Sales Taxes (as defined in the DoorDash Merchant Terms of Service) and any other applicable taxes and other governmental charges on the Referral Bonus.

**Bonus Payouts.** Referral Bonuses will be paid out with Merchant's regularly scheduled payouts from DoorDash, within 60 days of the Referral Bonus being earned.

**Restrictions; Modification; Termination.** Merchant will be disqualified and will not receive Referral Bonuses if DoorDash determines that the Referred Merchant has previously created a DoorDash merchant account. DoorDash also reserves the right to withhold or invalidate Referral Bonuses obtained through this Merchant Referral Program if DoorDash determines or believes that the Referral Bonus (or any order through a Referred Merchant) was received in error, fraudulently, illegally, or in violation of these terms and conditions or any other applicable agreement.
